ODU's Dragas Center for Economic Analysis and Policy: Increasing COVID-19 Cases in Hampton Roads Present Another Challenge to Recovery

Another 14,221 individuals file initial claims locally; continued claims decline to 79,361.

Norfolk, VA – (July 30, 2020) – Nonseasonally adjusted data from Virginia's Employment Commission shows for the week ending July 25, 14,221 individuals in the Virginia Beach-Norfolk-Newport News ("Hampton Roads") Metropolitan Statistical Area filed an initial claim for unemployment insurance, an increase of 2,389 from the prior week. The number of continued claims decreased by 2,008 to 79,361.

"With average daily COVID-19 infections on the rise and new restrictions on social gatherings implemented in the region this week, we expect continued challenges to employment in the coming weeks," said Robert McNab, director of the Dragas Center. "The expiration of expanded unemployment benefits under the CARES Act coupled with an expiration of the moratorium on federal evictions may lead to a rise in evictions and foreclosures in the coming months. As uncertainty increases, consumers may decide to slow spending, which could stall growth in the region."

Newly released data from Virginia's Employment Commission and the Bureau and Labor Statistics shows Hampton Roads added 15,800 jobs in June. However, when compared to June 2019, the region is still down approximately 61,800 jobs. The largest gain was in the leisure and hospitality sector, which added 9,600 in June. Local governments experienced the largest loss, shedding 1,300 jobs between May and June of 2020.

"In Hampton Roads, initial claims for unemployment benefits rose to their highest level since late April. While continued claims have declined for four straight weeks, the number of workers in region receiving benefits still accounts for approximately 9.3% of the June labor force," said Dominique Johnson, research associate at the Dragas Center. "Even before the recent outbreak of COVID-19 infections, the region's dependence on tourism has left it especially vulnerable to the current recession. The latest data shows that while the unemployment rate in Hampton Roads fell slightly in June from 10.0% to 9.6%, it remains the highest among all the metropolitan areas in the Commonwealth."

Note 1: Advance claims are not directly comparable to claims reported in prior weeks. Advance claims are reported by the state liable for paying the unemployment compensation, whereas previous weeks' reported claims reflect claimants by state of residence. In addition, claims reported as "workshare equivalent" in the previous week are added to the advance claims as a proxy for the current week's "workshare equivalent" activity.

Note 2: Data from the Virginia Employment Commission. Reported state totals will vary because not all reported claims are included in the announced data. Only intrastate claims are included in the data.
